Highway planned for Strawberry Hill SHS to be demolished

Connecticut governor, William O'Neill, and the Connecticut state legislature recently approved the construction of a new highway which will run through many Fairfield County cities including Stamford.

In Stamford, the highway will be built in the Newfield Avenue/Strawberry Hill Avenue area. This means that Stamford High School will have to be torn down.

The proposal to build this new highway was approved on January 4, but information about the bill was not released to the press until March 20.

The new expressway is being built to allow easier access to the Stamford Town Center for all Connecticut and Westchester County residents. Therefore, it will be named STC-95 (Stamford Town Center 95).

The expected cost of STC-95 is 50 million dollars. However, the legislature believes that federal grants along with increased revenue for the Town Center will offset the cost.

At his latest news conference, Governor O'Neill stated, ''I feel that this highway will benefit all of Connecticut. It is such a drag to keep changing roads to get to the Town Center. I believe I am doing a service to all those faithful shoppers in Connecticut and Westchester County."

This feeling of approval has also been seconded by many highranking officials in Connecticut such as Senator Christopher Dodd and Representative Stewart B. McKinney.

In Stamford, praise for the proposal has been heard far and wide. Mayor Thom Serrani said, "Gee, this is great. Now I can put re-election posters along the new highway."

Serrani also believes that, even though more people will be thrown out onto the streets without food or shelter, and many students will go without an education, the road will provide Stamford with more revenue which can be put into the construction of a new golf course.

The Stamford Board of Education president, Mrs. Roslyn Nesin, also sides with the mayor. "I like STC-95 because I will have one less high school to worry about after Stamford High is gone. Besides, my son will already have graduated."

One would expect the main opposition to this proposal to come from the faculty and students of Stamford High. However, this assumption is incorrect. Most people in SHS are in total agreement with the proposal. The biggest supporters are the administrators. Mr. Nast said, "Thank God the highway's coming through. Now I don't have to deal with these

every day. I can finally go to Hollywood and pursue an acting career."
